

**PARAGUAY VISA**

Documents	Particulars
<b>Passports</b>	<ul style="list-style-type: none"> <li>* Original Valid Passport. The passport should have a minimum validity of one year from the intended date of entry in to Paraguay</li> <li>*Colour Copy of Passport (1st, 2nd and Last page) as well as copy of any previous Paraguay visas.</li> </ul>
<b>Photographs</b>	* Two photographs of size 2x2, full face capture and a white background.
<b>Visa Forms</b>	<ul style="list-style-type: none"> <li>*Duly filled visa forms by the applicants with signatures</li> <li>* Signatures for children (below 18 years) to have both parents's signatures along</li> </ul>
<b>Covering Letter</b>	<ul style="list-style-type: none"> <li>* A covering letter from the Applicant addressing The Visa Officer, Embassy of the Republic of Paraguay</li> <li>* The Covering Letter should brief the profile of the applicants and the purpose of travel with travel dates</li> <li>* Covering Letter can be on a plain paper for individuals and on the company letterhead for officials / sponsored applicants</li> </ul>
<b>Bank Statements</b>	<ul style="list-style-type: none"> <li>* Original 6 months personal and company's bank statements with the seal and signature from the bank and showing the applicant's name and address.</li> <li>* Bank statements should be of a closing date closer to the date of visa application (A4 size preferred)</li> <li>*Copy of credit card</li> </ul>
<b>Itinerary / Air tickets</b>	* A copy of a paid flight Ticket showing both entry and exit from Paraguay
<b>Purpose of Travel / Accommodation</b>	<ul style="list-style-type: none"> <li>* An Invitation letter addressed to Minister Ruben Benitez Palma, Director of Passports and Consular Services, Ministry of Foreign Affairs, Asuncion, Paraguay.</li> <li>*An Invitation letter addressed to Minister Brígido Lezcano Britos, Charge d'affaires a.i., Embassy of Paraguay, New Delhi-India</li> <li>*A reference letter from the Employer/Request Letter. (Business-copy of company registration)</li> <li>*Police Clearance certificate Apostille by Ministry of External Affairs -India.</li> <li>* Any proof of your accommodation/ purpose at the destination/ Booking Certificate and payment receipts from the tour operator.</li> <li>* Copies of confirmed hotel, guest house or motel booking with the name of the applicants showing.</li> </ul> <p>For minors:</p> <ul style="list-style-type: none"> <li>- birth certificate</li> <li>-in cases where one parent has full custody over the child, the family court order has to be attached.</li> <li>-Certified copies of ID/passport of both parents</li> <li>-The notarized parental authorization signed by both parents or guardians is attached if the minor is to be travelling.</li> <li>* For conference, seminars, arts and sports activities, the organizer has to directly send an invitation to the Embassy's fax in advance.</li> </ul>
<b>Notes</b>	<p><b>*Application must be submitted 30 days before travelling.</b></p> <p><b>*All documents must be color scanned in jpg format with Resolution 75 DPI and mailed to <a href="mailto:indiaembaparsc@mre.gov.py.com">indiaembaparsc@mre.gov.py.com</a></b></p> <p><b>*All documents have to be submitted in original on the date of personal interview which will be informed by the Embassy.</b></p>
