

**BELARUS BUSINESS VISA**

Indian nationals can avail Visa- free entry upto 5 days with entry and exit only through the Minsk National Airport provided they fulfill the below conditions :

\*they have a valid (not expired) multiple-entry visa of one of the European Union or the Schengen Area member states bearing the European Union or the Schengen Area border entry stamp

\*they have financial means of at least 25 Euro (or equal amount in dollars or Belarusian rubles) for each day of stay

\*they have medical insurance with coverage for at least 10,000 Euros that covers the territory of Belarus.

\*they have flight tickets with confirmation of departure from Minsk National Airport within 5 days from the date of entry.

Documents	Particulars
<b>Passports</b>	<ul style="list-style-type: none"> <li>* The Applicant should have a passport valid for at least 6 months from the date of application of visa</li> <li>* Original old passport booklets if any</li> </ul>
<b>Photographs</b>	* 2 recent photographs of size 35x 45 mm, white background and 70-80% face coverage
<b>Visa Forms</b>	* One visa form (photocopy allowed)
<b>Covering Letter</b>	<ul style="list-style-type: none"> <li>* A covering letter per individual / family/ company addressed to The Visa Officer, The Consulate General of Belarus</li> <li>* The Covering Letter should brief the profile of the applicants and the purpose of travel with travel dates</li> <li>* Covering Letter can be on a plain paper for individuals and on the company letterhead for officials / sponsored applicants</li> </ul>
<b>Bank Statements</b>	<ul style="list-style-type: none"> <li>* Original 3 months personal and company's bank statements with the seal and signature from the bank</li> <li>* Bank statements should be of relevant and active accounts which shows the proof of funds and income</li> <li>* Bank statements should be of a closing date closer to the date of visa application (A4 size preferred)</li> </ul>
<b>Itinerary / Air tickets</b>	* Return airtickets with all internal flight / train tickets if any
<b>Purpose of Travel / Accommodation</b>	<ul style="list-style-type: none"> <li>* An Original letter of visa support from an Organization in Belarus typed on its official letter-head and certified with a company seal</li> <li>* If the inviting company is a private organization then the Company Registration Certificate is required, duly notarized in Belarus.</li> <li>* A document, that proves the necessity of multiple visits to the Republic of Belarus during the requested period of visa validity, i.e. a copy of a contract (cooperation agreement) between a Belarusian legal entity and foreign citizen or foreign organization where he/she works, that confirms the existence of stable business connection</li> </ul>
<b>Travel Insurance</b>	* Medical Insurance with minimum coverage on EUR 10,000
<b>Personal Presence</b>	<b>*Personal presence of the Applicant is mandatory</b>
<b>Disclaimers</b>	<ul style="list-style-type: none"> <li>* The above list of documents are the standard requirements for the visa application. The Embassy / Consulate/ High Commission/ Application Centres hold the rights to demand further documents for verification.</li> <li>* BPVS offers Visa Facilitation services to our customers against a Service Fee</li> <li>* BPVS at no stage guarantees the outcome of any visa application.
