

## BELARUS VISITOR VISA

Indian nationals can avail Visa- free entry upto 5 days with entry and exit only through the Minsk National Airport provided they fulfill the below conditions :

- \*they have a valid (not expired) multiple-entry visa of one of the European Union or the Schengen Area member states bearing the European Union or the Schengen Area border entry stamp
- \*they have financial means of at least 25 Euro (or equal amount in dollars or Belarusian rubles) for each day of stay
- \*they have medical insurance with coverage for at least 10,000 Euros that covers the territory of Belarus.
- \*they have flight tickets with confirmation of departure from Minsk National Airport within 5 days from the date of entry.

Documents	Particulars
<b>Passports</b>	<ul style="list-style-type: none"> <li>* The Applicant should have a passport valid for at least 6 months from the date of application of visa</li> <li>* Original old passport booklets if any</li> </ul>
<b>Photographs</b>	* 2 recent photographs of size 35x 45 mm, white background and 70-80% face coverage
<b>Visa Forms</b>	* One visa form (photocopy allowed)
<b>Covering Letter</b>	<ul style="list-style-type: none"> <li>* A covering letter per individual / family/ company addressed to The Visa Officer, The Consulate General of Belarus</li> <li>* The Covering Letter should brief the profile of the applicants and the purpose of travel with travel dates</li> <li>* Covering Letter can be on a plain paper for individuals and on the company letterhead for officials / sponsored applicants</li> </ul>
<b>Bank Statements</b>	<ul style="list-style-type: none"> <li>* Original 3 months personal and company's bank statements with the seal and signature from the bank</li> <li>* Bank statements should be of relevant and active accounts which shows the proof of funds and income</li> <li>* Bank statements should be of a closing date closer to the date of visa application (A4 size preferred)</li> </ul>
<b>Itinerary / Air tickets</b>	* Return air tickets with all internal flight / train tickets if any
<b>Purpose of Travel / Accommodation</b>	<ul style="list-style-type: none"> <li>* An original invitation, issued by the local unit of the Citizenship and Migration Department of the Ministry of Internal Affairs of the Republic of Belarus</li> <li>* An official confirmation of serious illness or death of a close relative or spouse, a death certificate (If applicable)</li> <li>* A letter of visa support of a Belarusian healthcare institution or contract for medical services with a Belarusian healthcare institution (For medical treatment)</li> <li>* For participation in sport and cultural events – an original letter of visa support of a legal entity, issued on the letter-head with the full name of the entity, its location and telephone number and an obligation assurance that the applicant will observe all rules of stay within the Republic of Belarus.</li> <li>* For religious reasons – an original letter of visa support of a religious association, issued on a letter-head with the full name of the religious association, its location and telephone number, and an obligation assurance that the applicant will observe all rules of stay within the Republic of Belarus.</li> </ul>
<b>Travel Insurance</b>	* Medical Insurance with minimum coverage on EUR 10,000
<b>Personal Presence</b>	<b>*Personal presence of the Applicant is mandatory</b>
<b>Disclaimers</b>	<ul style="list-style-type: none"> <li>* The above list of documents are the standard requirements for the visa application. The Embassy / Consulate/ High Commission/ Application Centres hold the rights to demand further documents for verification.</li> <li>* BPVS offers Visa Facilitation services to our customers against a Service Fee</li> <li>* BPVS at no stage guarantees the outcome of any visa application.
