Documents	Particulars
Passports	<ul style="list-style-type: none"> * Original Valid Passport. The passport should have a minimum validity of one year from the intended date of entry in to Paraguay *Colour Copy of Passport (1st, 2nd and Last page) as well as copy of any previous Paraguay visas.
Photographs	* Two photographs of size 2x2, full face capture and a white background.
Visa Forms	<ul style="list-style-type: none"> *Duly filled visa forms by the applicants with signatures * Signatures for children (below 18 years) to have both parents's signatures along
Covering Letter	<ul style="list-style-type: none"> * A covering letter from the Applicant addressing The Visa Officer, Embassy of the Republic of Paraguay * The Covering Letter should brief the profile of the applicants and the purpose of travel with travel dates * Covering Letter can be on a plain paper for individuals and on the company letterhead for officials / sponsored applicants
Bank Statements	<ul style="list-style-type: none"> * Original 6 months personal and company's bank statements with the seal and signature from the bank and showing the applicant's name and address. * Bank statements should be of a closing date closer to the date of visa application (A4 size preferred) *Copy of credit card
Itinerary / Air tickets	* A copy of a paid flight Ticket showing both entry and exit from Paraguay
Purpose of Travel / Accommodation	<ul style="list-style-type: none"> * An Invitation letter addressed to Minister Ruben Benitez Palma, Director of Passports and Consular Services, Ministry of Foreign Affairs, Asuncion, Paraguay. *An Invitation letter addressed to Minister Brígido Lezcano Britos, Charge d'affaires.i., Embassy of Paraguay, New Delhi-India *A reference letter from the Employer/Request Letter. (Business-copy of company registration) *Police Clearance certificate Apostille by Ministry of External Affairs -India. * Any proof of your accommodation/ purpose at the destination/ Booking Certificate and payment receipts from the tour operator. * Copies of confirmed hotel, guest house or motel booking with the name of the applicants showing. For minors: <ul style="list-style-type: none"> - birth certificate -in cases where one parent has full custody over the child, the family court order has to be attached. -Certified copies of ID/passport of both parents -The notarized parental authorization signed by both parents or guardians is attached if the minor is to be travelling. * For conference, seminars, arts and sports activities, the organizer has to directly send an invitation to the Embassy's fax in advance.
Notes	<p>*Application must be submitted 30 days before travelling.</p> <p>*All documents must be color scanned in jpg format with Resolution 75 DPI and mailed to indiaembaparsc@mre.gov.py.com</p> <p>*All documents have to be submitted in original on the date of personal interview which will be informed by the Embassy,</p>
