Documents	Particulars
<b>Passports</b>	* Original Passport with atleast 6 months validity and atleast 2 blank pages. * Original old passport booklets if any
<b>Photographs</b>	* 3 photographs each * White background; Glossy finish; 80% face coverage with a little shoulder to be seen; Eyes and face to be clearly visible; Dimensions: 45mm x 35mm
<b>Visa Forms</b>	* Duly filled visa forms by the applicants (available on the links below) with signatures * Signatures for children (below 18 years) to have both parents's signatures along
<b>Abstract of Screenplay</b>	*Abstract of screen-play in English language, detailing the intended scenes and locations to be shoot in Austria
<b>Proof of funds (production company):</b>	*Bank statements for the last three (3) months and / or other financial resources available
<b>ITR of production company</b>	*Income Tax Acknowledgement / ITR-V for the last three (3) years
<b>List of crew members</b>	*List of crew members with detailed kind of activity of each member, designation and justification of its uniqueness
<b>Production company</b>	*Cover letter detailing its professional background and filming history *Certificae of registration with the Indian Motion Pictures Producers Association/Film Chamber of Commerce
<b>Crew member</b>	*Professional curriculum (previous work history) with references and contacts from previous productions  * ID from either Cine Artist Association of India/ Film Federation of India. * Evidence of professional education; affiliation with industrial union / occupational group *Salary certificate of the last three (3) months of present occupation (if applicable) *Original bank statements for the last three (3) months and / or other financial resources * Copy of the present passport (data pages, pages with evidence of previous visa, travel) * Original(s) of previous passport(s) or proof of loss
<b>Austrian Business Partner</b>	* Copy of Business License in Austria ("Gewerbeberechtigung") * Invitation letter detailing its professional background and filming history forwarded directly to the Austrian Embassy * Itinerary of indented shoot together with filming permits of each location
<b>Electronic letter of guarantee of sponsor</b>	"EVE - Elektronische Verpflichtungserklärung" should be obtained by the sponsor from "Fremdenpolizeibehörde" (local Police Authority) of the particular district in Austria.
<b>Round-trip flight reservations - travel itinerary</b>	Airline reservation and proof of other means of travel within Austria/EU
<b>Proof of Accommodation</b>	* Hotel reservation in Austria and other EU Member States
<b>Travel Insurance</b>	* Valid Travel Insurance from the Embassy approved companies which covers the days of travel with minimum coverage of EUR 30,000
<b>Disclaimers</b>	* The above list of documents are the standard requirements for the visa application. The Embassy / Consulate/ High Commission/ Application Centres hold the rights to demand further documents for verification. * The Embassy / Consulate / High Commission hold the rights to cal the applicant for a Personal Interview if needed * BPVS offers Visa Facilitation services to our customers against a Service Fee * BPVS at no stage guarantees the outcome of any visa application. The decisions on the Visa applications would be at the sole discretion of the respective Embassy/ Consulate / High Commission
