

BELARUS BUSINESS VISA

Indian nationals can avail Visa- free entry upto 5 days with entry and exit only through the Minsk National Airport provided they fulfill the below conditions :

*they have a valid (not expired) multiple-entry visa of one of the European Union or the Schengen Area member states bearing the European Union or the Schengen Area border entry stamp

*they have financial means of at least 25 Euro (or equal amount in dollars or Belarusian rubles) for each day of stay

*they have medical insurance with coverage for at least 10,000 Euros that covers the territory of Belarus.

*they have flight tickets with confirmation of departure from Minsk National Airport within 5 days from the date of entry.

Documents	Particulars
Passports	* The Applicant should have a passport valid for at least 6 months from the date of application of visa * Original old passport booklets if any
Photographs	* 2 recent photographs of size 35x 45 mm, white background and 70-80% face coverage
Visa Forms	* One visa form (photocopy allowed)
Covering Letter	* A covering letter per individual / family/ company addressed to The Visa Officer, The Consulate General of Belarus * The Covering Letter should brief the profile of the applicants and the purpose of travel with travel dates * Covering Letter can be on a plain paper for individuals and on the company letterhead for officials / sponsored applicants
Bank Statements	* Original 3 months personal and company's bank statements with the seal and signature from the bank * Bank statements should be of relevant and active accounts which shows the proof of funds and income * Bank statements should be of a closing date closer to the date of visa application (A4 size preferred)
Itinerary / Air tickets	* Return airtickets with all internal flight / train tickets if any
Purpose of Travel / Accommodation	* An Original letter of visa support from an Organization in Belarus typed on its official letter-head and certified with a company seal * If the inviting company is a private organization then the Company Registration Certificate is required, duly notarized in Belarus. * A document, that proves the necessity of multiple visits to the Republic of Belarus during the requested period of visa validity, i.e. a copy of a contract (cooperation agreement) between a Belarusian legal entity and foreign citizen or foreign organization where he/she works, that confirms the existence of stable business connection
Travel Insurance	* Medical Insurance with minimum coverage on EUR 10,000
Personal Presence	*Personal presence of the Applicant is mandatory
Disclaimers	* The above list of documents are the standard requirements for the visa application. The Embassy / Consulate/ High Commission/ Application Centres hold the rights to demand further documents for verification. * BPVS offers Visa Facilitation services to our customers against a Service Fee * BPVS at no stage guarantees the outcome of any visa application.
