

BELARUS TOURIST VISA

Indian nationals can avail Visa- free entry upto 5 days with entry and exit only through the Minsk National Airport provided they fulfill the below conditions :

*they have a valid (not expired) multiple-entry visa of one of the European Union or the Schengen Area member states bearing the European Union or the Schengen Area border entry stamp

*they have financial means of at least 25 Euro (or equal amount in dollars or Belarusian rubles) for each day of stay

*they have medical insurance with coverage for at least 10,000 Euros that covers the territory of Belarus.

*they have flight tickets with confirmation of departure from Minsk National Airport within 5 days from the date of entry.

| Photographs | * 2 recent photographs of size 35x 45 mm, white background and 70-80% face coverage |
| Visa Forms | * One visa form (photocopy allowed) |
| Covering Letter | <ul style="list-style-type: none"> * A covering letter per individual / family/ company addressed to The Visa Officer, The Consulate General of Belarus * The Covering Letter should brief the profile of the applicants and the purpose of travel with travel dates * Covering Letter can be on a plain paper for individuals and on the company letterhead for officials / sponsored applicants |
| Bank Statements | <ul style="list-style-type: none"> * Original 3 months personal and company's bank statements with the seal and signature from the bank * Bank statements should be of relevant and active accounts which shows the proof of funds and income * Bank statements should be of a closing date closer to the date of visa application (A4 size preferred) |
| Itinerary / Air tickets | <ul style="list-style-type: none"> * Return airtickets with all internal flight / train tickets if any * Day wise itinerary of the tour |
| Purpose of Travel / Accommodation | <ul style="list-style-type: none"> * A letter of visa support of a Belarusian tourist company, issued on a letter-head with the full name of the tourist company, its location and telephone number and an obligation assurance that the applicant will observe all rules of stay within the Republic of Belarus. * A letter of visa support of a sanatorium-and-spa resort or recreation center, issued on a letter-head with its full name, location and telephone number, purpose, period of stay of a foreign citizen, services rendered, confirmation of the voucher reservation and full or partial prepayment for the services and an obligation assurance that the applicant will observe all rules of stay within the Republic of Belarus. * A letter of visa support of a representative of farm tourism business with its name and address, purpose, period of stay of a foreign citizen, services rendered and an obligation assurance that the applicant will observe all rules of stay within the Republic of Belarus. * Hotel booking confirmation on the letterhead of hotel in Belarus (Booking.com vouchers are not allowed) * For Private Apartments, rental agreement with the landlord, proof that the landlord is the owner of the property, certificate of the registration of a private unitary enterprise. * For Minors : A copy of full Birth Certificate (contains information about parents) and copies of passports of the applicant's parents (legal representatives) |
| Travel Insurance | * Medical Insurance with minimum coverage on EUR 10,000 |
| Personal Presence | *Personal presence of the Applicant is mandatory |
